Application submission

:: Eligibility

- Among those belonging to "universities" (including affiliated research institutes) and "research institutions" under Article 2 of the Academic Promotion Act, those who can apply in the name of the head of the relevant institution.

- In principle, each person must apply for one project within the same project (bilateral research exchange support).
- This project is an institution-specific project of the National Research Foundation of Korea, and is not included in the national R&D project research project award cap system (2 books/3 credits in the humanities and social sciences field, 3 books/5 credits in the science and technology field, etc.).
- A person who is or is planning to participate as a research director in the National Research Foundation of Korea's institution-specific international cooperation project* as of the scheduled research start date.
